- 2. Do we have agreements with any other governments to receive deported Hmong or Lao residents of the United States?
- 3. How many people would be subject to deportation under this agreement?
- 4. Has the Department of State attempted to study the impact this agreement would have on communities in the US?
- 5. Has the Lao government made any commitments about where deported individuals will be resettled and housed? If so, what are the details of those commitments?

As you know, the State Department's most recent Country Report on Human Rights Practices for Laos raises major concerns about conditions in the country. Deporting U.S. residents there could easily put them at risk. I strongly oppose any efforts to separate families that have been in the United States for decades by knowingly sending U.S. residents into dangerous and potentially life-threatening circumstances.
